SUBJECT: 2019 STATEMENT OF REMUNERATION AND EXPENSES FOR MEMBERS OF COUNCIL AND COUNCIL APPOINTMENTS TO BOARDS AND OTHER BODIES

RECOMMENDATION

That, report FIN 20-05, 2019 Statement of Remuneration and Expenses for Members of Council and Council Appointments to Boards and Other Bodies be received for information.

BACKGROUND

Section 283 of the Municipal Act deals with remuneration and expenses that can be paid to Members of Council.

Section 284 of the Municipal Act requires that the treasurer shall in each year provide to the council of the municipality an itemized statement of remuneration and expenses paid in the previous year to:

- (a) each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- (b) each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and
- (c) each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.

The portion of Council's remuneration that is tax-free is considered an allowance for any expenses incurred in the performance of their duties. Remuneration is reported on a cash basis (T4) rather than on an accrual basis and therefore does not reflect the amounts reported for accounting purposes. The attached statement reflects the remuneration paid by the Town of Grimsby as authorized by By-Law 20-33.
