### The Portfolio

Reporting to the Environmental Services Supervisor, the Environmental Services Operator assists in maintaining the Town's drinking water distribution system and wastewater collection system. This involves performing skilled functions related to maintenance, construction, monitoring and rehabilitation of the water distribution system and wastewater collection system, safely and efficiently, as a Licensed Water and Wastewater Operator. The purpose of position is to help to Environmental Service Division maintain compliance with provincial drinking water and wastewater legislation, Town by-laws and standards, and to perform other water/wastewater related functions within the Corporation as required.

### The Candidate

As a candidate for this position, you possess a secondary school diploma and have two (2) years related experience in water and wastewater maintenance. In addition, you have a Meter Installer License/Certificate, Licensed Drinking Water Operator Certificate – Class 1, Licensed Wastewater Operator Certificate – Class 1, AWWA Cross Connection Control Specialist, OTM Book 7 – Traffic Control Training, Confined Space Entry Training, and a valid Class "D" driver's license with "Z" endorsement for air brakes with a clean driving record.

### **Duties and Responsibilities:**

#### **1. Wastewater Operations and Maintenance (35%)**

- 1.1 Responsible for providing wastewater related functions which are consistent with the requirements of a Licensed Wastewater Operator for a wastewater collection system.
- 1.2 Performing various activities associated with construction, maintenance or general operation of a wastewater collection system.
- 1.3 Performing rodding, video inspections and sewer lateral replacements.
- 1.4 Completing restoration activities where necessary, following system repairs and communicating with the property owners where appropriate.
- 1.5 Completing sewer flushing, maintenance holes parging/sealing, ladder replacement and frame adjustments.
- 1.6 Completing lateral repairs and monitoring.
- 1.7 Responsible for conducting sewer/lateral blockage removals.
- 1.8 Performing dye and smoke testing activities where required.
- 1.9 Perform inspections and monitoring of wastewater overflows.
- 1.10 Responsible for carrying out corrective actions in response to spills or combined sewage overflows including providing the required notification/reports to the appropriate agencies.
- 1.11 May be required to provide direct supervision for Operators in Training when they are performing Operator Functions.
- 1.12 Operating in accordance with the applicable legislation, Town by-laws, policies, procedures and guidelines.

#### **2. Drinking Water (55%)**

- 2.1 Responsible for providing drinking water related functions which are consistent with the requirements of a Licensed Water Operator for a drinking water distribution system and in accordance with the Town of Grimsby Drinking Water Quality Management System.
- 2.2 Responsible for performing various activities associated with construction, maintenance or general operation of a drinking water distribution system or other small drinking water systems.
- 2.3 Carry out water quality testing including; chlorine residual test, bacteriological sampling lead and, HAA and THM, tests and respond to Adverse Impacts and Corrective Actions immediately upon becoming aware in accordance with the Town's Standard Operational Guidelines.
- 2.4 Conduct tests for maintenance and operational checks and evaluate results on the Town's systems in accordance with O.Reg 170/03 and adjust or regulates in

- accordance with the Town's Standard Operational Guideline, or manufacturer's instructions.
- 2.5 Perform activities associated with the installation of new water services, installation of new or replacement water meters, performing wet tapping on a charged water system.
  - 2.6 Performing activities associated with fire hydrant and watermain valve operation and maintenance.
  - 2.7 Controlling system flows and pressure, performing system isolations and re-pressurizations and coordinating system functions with Region of Niagara Licensed Operators where required.
  - 2.8 Completes tasks associated with the operation and maintenance of the bulk water filling station and small drinking water systems.
  - 2.9 Performs maintenance checks, operational checks and water quality sampling, evaluating the results and making adjustments where required.
  - 2.10 Carrying out corrective actions in response to adverse water quality incidents or equipment alarms including providing the required notification/reports to the appropriate agencies.
  - 2.11 Provides supervision for Operators in Training when they are performing Operator Functions.
  - 2.12 Provides supervision and monitoring over work being performed by non-licensed persons and contractors that would normally require a Licensed Water Operator.
  - 2.13 Act as the Operator in Charge where designated by the Environmental Services Supervisor or designate.
  - 2.14 Act as the back-up Overall Responsible Operator where designated by the Environmental Services Supervisor or designate.
  - 2.15 Operate in accordance with the Safe Drinking Water Act, 2002, Ontario Regulation 170/03 and 128/04, other applicable legislation, Town by-laws, policies, procedures and guidelines.

### **3. Equipment Operation (5%)**

- 3.1 Performs heavy equipment operations within the Environmental Services Division including the operation of combination sewer/hydro vacuum trucks, dump trucks and all other heavy equipment requiring specialized training and/or licenses.
- 3.2 May be required to operate backhoe (front bucket only) to perform routine tasks.
- 3.3 Responsible for ensuring all excavations, trenching and work performed around and within the work site are carried out in accordance with the Occupational Health and Safety Act and Regulations for Construction Projects.

### **4. Other (5%)**

- 4.1 In the absence of the Meter Reader or as otherwise directed, cover all roles and responsibilities, including meter reading, final meter reads, pick-up/drop-off of interoffice and post office mail.
- 4.2 Completes all required documentation and reporting as required by Town policies and procedures as well as the Highway Traffic Act, including Circle Checks, Equipment use logs, Hours of service logs, timesheets, etc.
- 4.3 Responsible for completing utility locate activities associated with the Town's underground infrastructure, including locating drinking water system infrastructure (watermain, water services, valves, curb stops, etc.) and storm sewer and

- wastewater infrastructure (sewers mains, sewer laterals, etc.) to prevent damage during excavation.
- 4.4 Aides in operating the Town's winter maintenance equipment when required.
- 4.5 Work in a safe manner in accordance with the Occupational Health and Safety Act, associated regulations, other applicable legislation, Town by-laws, policies, procedures and guidelines.
- 4.6 Assist with other duties within the Environmental Services or Roads Operation Divisions as assigned.
- 4.7 Other related duties, as assigned
