Reporting to the Transportation Services Supervisor, the Transportation Services Operator (MT II) is responsible for maintaining the road systems, storm drainage systems and cemetery within the Town of Grimsby and other related functions requiring skilled and safe operating of trucks and other licensed and unlicensed equipment. To perform a wide variety of these road-related tasks as well as performing general maintenance functions within the Corporation as required.

### The Candidate

As a candidate for this position, you have achieved a secondary school diploma and possess a valid class "D" drivers' license with "Z" endorsement, Book 7 – Traffic Control training, Confined Space Entry training, chainsaw operation certifications, OGRA Winter Maintenance Operations training, and standard First Aid/CPR-C. You have three (3) years of recent related experience in transportation operations/maintenance and are able to perform manual labour duties for the duration of a working shift. You possess strong customer service skills, and are able to work independently and as part of a team.

# Duties and Responsibilities:

# 1. Roads System Operations and Maintenance (90%)

- 1.1 Responsible for tasks primarily related to the maintenance and construction of the Town's road infrastructure and other related assets and areas of responsibility including storm water system, trees, town right-of-way maintenance.
- 1.2 Responsible for operating heavy equipment for the purposes of haulage of aggregates, fill, tree trimmings, snow, sand, and gravel.
- 1.3 Implements various construction and repair tasks of curbs, sidewalks, catch basins, culverts, shoulders, and various road surfaces.
- 1.4 Responsible for operating winter maintenance equipment including 2- and 5-ton plow trucks, sidewalk plows and snow blowers.
- 1.5 Operate front end loader, backhoe, tractor, street flusher, sweeper, snowplow equipment, wood chipper, compactors, compressors, grass mowers, dump trucks and small gas powered equipment.
- 1.6 Responsible for roadside grass mowing and town right-of-way maintenance.
- 1.7 Performs maintenance and minor repair of Town equipment and facilities as required.
- 1.8 Required to direct and control traffic as required, subject to being certified as a Traffic Control Person.
- 1.9 Responsible for performance of all general labour duties in maintenance and construction as it related to road related assets.
- 1.10 Responsible for maintenance and repair of street signs and line painting.
- 1.11 Carries out winter maintenance activities in compliance with the Town's Salt Management Plan and the Roads Quality Management System (RQMS).
- 1.12 Responsible to safely set up road closures and removals and notifies stakeholders.
- 1.13 Operates various pieces of licensed and unlicensed equipment including but not limited to, the following:
  - a) Pavement marking machine;
  - b) Sidewalk plows and attachments;
  - c) Compactor;
  - d) Snow blower;
  - e) Chainsaw and concrete saw;
  - f) Steam generator;
  - g) Sprayer;
  - h) Compressor and attachments;
  - i) Mower;
  - j) Various size pumps;
  - k) Tractor and attachments;
  - I) Asphalt roller;
  - m) <sup>1</sup>/<sub>2</sub> tonne pickup truck;

- n) Generators;
- o) 2 tonne truck and attachments; and
- p) Gas powered post hole auger.

## 2. Storm System Maintenance

- 2.1 Responsible for maintenance for storm water quality and quantity facilities as directed including repair of storm sewers and appurtenances, vegetation management, mowing and invasive plant removal.
- 2.2 Responsible for storm system inlet and outlet structure monitoring and inspections.
- 2.3 Responsible for driveway and cross culvert inspection, maintenance and installation as directed.

# 3. Town Tree and Brush Maintenance

- 3.1 Responsible for performing routine inspections of Town trees and where applicable providing trimming, brushing and general maintenance.
- 3.2 Responsible for post weather event tree and brush clean up.

# 4. Equipment Operation (5%)

- 4.1 Performs heavy equipment operations within the Roads Division including the operation of dump trucks and all other heavy equipment requiring specialized training and/or licenses.
- 4.2 May be required to operate backhoe (front bucket only) to perform routine tasks.
- 4.3 Responsible for ensuring all excavations, trenching and work performed around and within the work site are carried out in accordance with the Occupational Health and Safety Act and Regulations for Construction Projects.

### 5. Other (5%)

- 5.1 Works in a safe manner in accordance with the Occupational Health and Safety Act, associated regulations, other applicable legislation, Town by-laws, policies, procedures, and guidelines.
- 5.2 Completes all required documentation and reporting as required by Town policies and procedures as well as the Highway Traffic Act, including Circle Checks, Equipment use logs, Hours of service logs, timesheets, etc.
- 5.3 Assists in Environmental Services Division and other Department works as required.
- 5.4 Other related duties, as assigned.
- 5.5 Perform assigned work in the cemetery and acquire general knowledge of maintenance and burial procedures.
